WHEREAS, the recognition was granted to the institution namely Annai Madha College of Education, Trichy Main road Educheruvai, Akkanur Post, Tittagudi Taluk, Cuddalore District — 6066106, Tamil Nadu run by Charisthuva Madhakalvi Kalachara Samuga Niruvanam Charitable Trust, 50 West Street, Tittagudi — 606106, Cuddalore district, Tamil Nadu vide SRC (NCTE) order dated 20.02.2008 for conducting B Ed. course of one-year duration with an annual imake of 100 students

AND WHEREAS. on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. 20.10.2015 for its willingness of two units in B.Ed. course and adherence of provisions of new Regulations.

AND WHEREAS, provisional revised recognition order was issued to the institution on 25.02.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed before the SRC in its 369th meeting held on 28.01.2019 and the Committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision a Show Cause Notice was issued to the institution on 10.10.2019 and the institution did not submit any documents to Show Cause Notice till date.

AND WHEREAS, the matter was further considered by the Sub-Committee constituted by the SRC as per its decision taken in 380th Meeting. The Sub-Committee decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution.

AND WHEREAS, a Final Show Cause Notice was issued to the institution on dt. 05.08 2020 and the institution has submitted its reply on 17.08 2020.

AND WHEREAS, the compliance submitted by the institution on dt. 17.08.2020 and the matter was considered by the SRC in its 387^{th} Meeting held on 24^{th} & 25^{th} August 2020 as under: -

On the perusal of the reply submitted by the institution vide letter dt. 10.08.2020, Committee decided that the continuation order be issued to the Institution Annai Madha College of Education, Trichy Main road Educheruvai, Akkanur Post, Tittagudi Taluk, Cuddalore District – 6066106, Tamil Nadu for B.Ed programme for 2 basic units of 50 students each."

NOW THEREFORE, the SRC decided to permit the institution i.e. Annai Madha College of Education, SF No.76/2A, 2B, 3, 4A,4B,5, 7, 8, 9, 10, 11, 12,77/10B, 5A,5B, 6,7,8,9 Edaicheruvai (Vil.), Akkanur (P.O), Tittagudi (T.K.), Cuddalore (D.T.)-621716, Edaicheruvai Panchayat, Tamil Nadu for B.Ed. course run by Charisthuva Madhakalvi Kalachara Samuga Niruvanam Charitable Trust, 50 West Street, Tittagudi, Cuddalore District, Tamilnadu-606106 for continuation of recognition for B.Ed. course of two-years duration with an intake of 100 students (two units) subject to fulfilment of the following conditions:

- 1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc as applicable.

The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
